The grouping arrangement made by the Principal should be intimated to the External Examiners and Controller of Examinations at least two weeks before the commencement of Practical Examinations. The Practical Examinations are to be conducted only within the dates mentioned in this programme and on the fixed dates announced by the Principals. In case of violation of stipulated dates the Council reserves the right to withhold or cancel the result. Principals are also required to submit the Practical marks and Practical scripts in the Council within 7 (seven) days of completion of

Practical Examinations. The Examiners of Practical Examination should submit the mark foils and scripts to the Principal as soon as the Practical Examination is over. In case the Principals do not get the marks/scripts within the stipulated period; they must intimate this to Council. Date of submission of valued scripts/mark foils etc of Practical Examinations in Head office shall be notified latter on. All Principals / Headmasters/Headmistress are requested to circulate this programme well in advance in their respective institutions.

Further, it has come to the notice of the Council that letters mentioning dates of Practical Examinations to External Examiners appointed by the Council are not intimated by some Principals in time and other substitute External Examiners are appointed in their place. When External Examiners fail to turn up with sufficient grounds, the Principals/ Centre Superintendents can appoint External Examiners with prior permission of the Controller of Examinations. In the case of delay in communication to the Original External Examiners and alternative arrangements by the Principal / Centre Superintendent without intimate to Controller of Examinations in time will be seriously viewed and the Centre Superintendent will be held responsible for any action taken by the Council in this regard including withhold or cancellation of results.
